### FOREWORD

This manual is to help you understand national, state, and local programs that may assist you in finding or keeping temporary housing and shelter. However, this manual does not contain all you need to know about housing. If you need legal advice about a housing problem, you may want to talk to a lawyer. If you want to know if you are eligible for any of the programs or services listed, you should contact the program administrator or service provider directly. You should also contact the program administrator or services provider directly if you have questions about the programs or services.

The information listed in this manual is current as of May 2012. Because programs and services may change, the information in this manual may not remain accurate or up-to-date. There may also be programs and services where you live that are not in this guide. If you know of other services or programs that should be added, please feel free to tell us.

# **Definitions and Sources**

**Definitions of Terms:** 

The terms below are used in this manual. You may need to look over these terms often so that you can understand the information about a housing or rental program.

<u>Advocacy</u> – Support of or speaking out for a person, idea or belief.

<u>Area Median Income (AMI)</u> – The middle family income for an area. The AMI breaks up family income into two equal parts: one-half of incomes that are below a number and one-half of incomes that are above the same number. For example, the 2011 median income for the Columbia, SC area was \$63,600. This means that one-half of incomes in Columbia were less than \$63,600 and one-half of incomes in Columbia were more than \$63,600.

<u>Case Management</u> – The work done by skilled workers to care for your medical, physical, emotional, or social needs. The skilled worker keeps track of how you are doing and gets you the help that you need.

<u>Disability</u> – Under HUD rules, a disabled person is a person who has a physical or mental problem that keeps the person from being able to do one or more "major life activities". Some major life activities are walking, talking, hearing, seeing, breathing, learning, and taking care of yourself.

<u>DSS</u> – Department of Social Services; The state child welfare agency in South Carolina. DSS also gives help with Family Independence, Food Stamps, Child Care and Adult Protective Services.

<u>Elderly</u> – As used in this manual, an elderly person is a person who is 65 years old or older.

<u>FHA</u> - Federal Housing Administration; A part of the U.S. Department of Housing and Urban Development that insures mortgages.

<u>FHA-approved lender</u> – A lender approved by the Federal Housing Administration to make FHA loans.

<u>FHA loan</u> - A loan insured by the Federal Housing Administration and made by an FHAapproved lender under FHA rules.

<u>Graduated payments</u> – Loan payments that increase slowly over time. When making graduated payments, you make smaller payments on the loan at first. As time passes, your payments get bigger.

<u>Grant</u> – Money given for a certain use. Unlike with a loan, a grant usually does not have to be paid back. A grant can be given to a person or a company.

<u>Guaranty</u> – When one party promises to pay a debt or do something under a contract for another person in case that person does not pay or do what was agreed. For example, a company can promise to repay a loan for a person if that person does not pay the loan. The company's promise to repay the loan for the person is a guaranty.

<u>Home Loan Entitlement</u> – Under VA rules, this is the VA home loan benefit. For eligible veterans, the VA promises to pay the lender a certain amount of money if the veteran does not repay the loan. The entitlement is the amount the VA promises will be paid to the lender if the veteran does not repay the loan. The amount of entitlement a veteran has depends on many things. If you have questions about your entitlement amount, you can call the VA Loan Eligibility Center at 1-888-244-6711.

Housing Authority (HA) - The agency that runs the subsidized housing programs in an area.

 $\underline{HUD}$  – U.S. Department of Housing and Urban Development; This agency helps people with housing needs.

<u>HUD-approved lender</u> – A lender allowed by HUD to make loans to people who are trying to buy HUD property. A list of HUD-approved lenders can be found at <u>http://www.hud.gov/ll/code/llplcrit.html</u>.

<u>Low Income</u> – A person or family with an income between fifty percent (50%) and eighty percent (80%) of the area median income. In 2011, a single person living in the Columbia, SC area with an income of 36,150 or less would be low-income.<sup>1</sup>

<u>Manufactured Home</u> – A single-family house made in a factory that can be attached to land and used as a home. Not all manufactured homes are permanently fixed to a piece of land. A manufactured home is often called a mobile or a modular home.

<u>Modular Home</u> – A home that is built in parts in a factory. It is later taken to a piece of land and put together.

<u>Multifamily Housing</u> - A building made to house more than one family.

<u>Principal</u> – The amount of money owed as a debt before interest is added. The principal and the interest on a loan are added together with any charges for making the loan that you may owe. These amounts added together are the total price paid on a loan.

<u>Public Housing</u> – Housing that the government builds, owns, and manages. The government allows eligible people or families to rent the housing at a lower rate.

Public Housing Authority (PHA) – See Housing Authority

<u>Rehabilitation</u> – Improving or fixing something to the way it used to be.

<u>Rental Assistance</u> – Financial help that helps pay for housing costs.

<u>Resident</u> – A person who lives in a certain place.

<u>Right of Peaceful Enjoyment</u> – A tenant's right to live in a home in peace and without being disturbed. For example, if a landlord cuts off the electricity and water in a home that a tenant is living in, the tenant may argue that the landlord has interfered with his right of peaceful enjoyment of the home.

<u>Rural Development (RD)</u> – A part of the USDA that runs certain USDA rural housing programs.

<u>Rural Housing Service (RHS)</u> – Rural Housing Service; A part of Rural Development

<u>Single Family Housing</u> – A house or low-rise building made to house only one family.

<u>Subsidized Housing</u> – Housing where some or all of the rent is paid by the government. Examples of subsidized housing are elderly housing, Housing Choice Voucher housing, and public housing. <u>Supportive Services</u> – Services made to help a person who is ill or disabled. These services can include medical care, transportation, and help with cleaning or cooking.

<u>Sweat Equity</u> - When a buyer helps to build the house he is buying as part or complete payment for the house.

<u>Tenant</u> – A person who rents a home from another person or company.

<u>Transitional Housing</u> – Housing that limits how long a person can live there. Usually, the time limit is 2 years. Transitional housing is made to help a person until he or she can find a permanent place to live.

 $\underline{\text{USDA}}$  – U.S. Department of Agriculture; This agency gives help with housing in rural areas.

VA - U.S. Department of Veterans Affairs; This agency works with and gives help to U.S. veterans.

VA loan - A loan guaranteed by the U.S. Department of Veteran Affairs. VA loans are only available to certain people who served in the military.

 $\underline{VBA}$  – Veterans Benefits Administration; A part of the U.S. Department of Veteran Affairs that works with benefits for U.S. veterans.

<u>Very Low Income</u> – A person or family with an income that is less than fifty percent (50%) of the area median income. In 2011, a single person living in the Columbia, SC area with an income of \$22,600 or less would be very low-income.<sup>2</sup>

<u>Weatherization</u> – A way to help people save money on fuel bills and utilities, so they can save energy and have warmer homes. Weatherization is done by making changes to your home. These changes can include making sure doors and windows are sealed tightly. They can also include adding insulation to your home or fixing your heating system.

# <u>U.S. Department of Housing and Urban Development</u> (HUD)

#### I. <u>Single-Family Housing Programs</u>

These programs are run by the Federal Housing Administration (FHA). The FHA is part of the U.S. Department of Housing and Urban Development (HUD). Please call the FHA/HUD directly for more information about each program at 1-800-225-5342 (or 1-800-CALL-FHA).

#### a) <u>Counseling for Homebuyers, Homeowners, and Tenants (Section 106)</u>

This program is for people who want to buy a home through FHA/HUD. It is also for tenants in FHA/HUD property. The program gives advice on buying and renting a home. Advice is also given on foreclosure and eviction laws, home repairs, credit issues, and other important information for homeowners and tenants.

Counseling is given through HUD-approved housing counseling agencies. A list of HUD-approved counseling agencies in South Carolina is located at <u>http://www.hud.gov/offices/hsg/sfh/hcc/hcs.cfm?webListAction=search&searchst</u> <u>ate=sc</u> or by calling 1-800-569-4287. #### b) <u>One-to-Four-Family Home Mortgage Insurance (Section 203b)</u>

With this program, you can get a mortgage to pay for a home or to pay debt. If you use this program, you may have a lower down-payment. You may also be able to finance your closing costs, and may have a limit on lender fees. However, your mortgage can only be a certain dollar value. How high your mortgage can be depends on where you live. You can find out your area's mortgage limit by going to <u>https://entp.hud.gov/idapp/html/hicostlook.cfm</u>.

You must be able to make the down-payment. You must also make the monthly mortgage payments. You must be a good credit risk. The home you are buying must be the main place you will live. You can apply for this program through an FHA-approved lender. You can find out more about this program by going to <u>http://www.hud.gov/offices/hsg/sfh/ins/203b--df.cfm</u>.

#### c) <u>Mortgage Insurance for Disaster Victims (Section 203h)</u>

This program helps people who live in areas that the government has declared to be "disaster areas". It also helps people who have lost their homes due

to major disasters. This program gives you the choice to buy a new home or to fix the destroyed home. If you were renting a home that was destroyed or severely damaged by the disaster, you may also apply.

With this program, you do not have to pay a down-payment. Fees are limited. You will have to pay closing costs, mortgage insurance payments, and other fees. Your mortgage can only be a certain dollar value. How high your mortgage can be depends on where you live. You can find out your area's mortgage limit by going to <u>https://entp.hud.gov/idapp/html/hicostlook.cfm</u>.

You can apply for the program through an FHA-approved lender. All applications must be done within one (1) year from the date that the President declares the disaster. You can find out more about this program by going to <u>http://www.hud.gov/offices/hsg/sfh/ins/203h-dft.cfm</u>.

#### d) <u>Rehabilitation Loan Insurance (Section 203k)</u>

With this program, you can get a loan to fix or to buy and fix a home. The home being fixed must be at least one year old. HUD will decide what counts as an eligible improvement. Examples of eligible improvements are adding new appliances to the home or having structural work done on the home. In some situations, condominium units may also be fixed under this program.

If you use this program, you must be able to make a down-payment and monthly mortgage payments. Your mortgage can only be a certain dollar value. How high your mortgage can be depends on where you live. You can find out your area's mortgage limit by going to <u>https://entp.hud.gov/idapp/html/hicostlook.cfm</u>. You can find out more about this program by going to <u>http://www.hud.gov/offices/hsg/sfh/203k/203kabou.cfm</u>.

#### e) <u>Mortgage Insurance for Older, Declining Areas (Section 223e)</u>

This program helps homebuyers who cannot get mortgage insurance anywhere else to buy and fix a home in an older, declining urban area. This program can only be used with other mortgage insurance programs run by FHA/HUD.

If you use this program, you must be able to make the down-payment and make mortgage payments. You must also be a good credit risk. You can apply for this program through a HUD-approved lender. A list of HUD-approved lenders can be found at <u>http://www.hud.gov/ll/code/llslcrit.html</u>. This insurance is still available through HUD, however has been largely inactive in recent years.

#### f) Mortgage Insurance for Condominium Units (Section 234c)

This program provides mortgage insurance for people who buy a unit in a condominium building. The condominium building must have at least four units. With this program, you can make a low down-payment. You may be able to finance some of the closing costs. Lenders' fees and the amount of the mortgage loan may also be limited. Other rules will also apply if the unit is in a building that was previously changed from rental housing to condominiums.

To use this program, you must plan to make the condominium unit the main place you will live. You must also be a good credit risk. You can apply through an FHA-approved lender. This program is still in use, though insurance is now provided mainly through section 203b (one-to-four-family home mortgage insurance).

#### g) Graduated Payment Mortgage Insurance (Section 245)

This program is for people who have a limited income, but expect their income to rise later. With this program, you make small mortgage payments at first. Over time, the mortgage payments increase little-by-little. You can choose from five plans. Each plan will raise your mortgage payments each year for up to ten (10) years. By using this program, you can buy a home sooner than with a regular mortgage. However, because smaller payments are made at first, you may pay more interest over the length of the loan than with a regular mortgage.

You may have a lower down-payment than normal with this program. You may also be able to finance some of the closing costs. You may have a limit on the lenders' fees you will have to pay. Only people who can prove that they will have an increase in income qualify for this program. You must be a good credit risk. You must be able to pay the down-payment and monthly mortgage payments. The home must be the main place you will live. You can apply through an FHA-approved lender. You discover more about this program by visiting http://portal.hud.gov/hudportal/HUD?src=/hudprograms/gpm.

#### h) <u>Growing Equity Mortgage Insurance (Section 245a)</u>

Like the Graduated Payment Mortgage Program (Section 245), this program helps a family with a small income that will rise later to buy a home. You can still make mortgage payments that increase over time. However, with this program, you can choose to apply the increases in your monthly payments directly to the principal balance of the mortgage instead of to the interest. That means that the amount of interest you pay over time may be lower. It also means that the length of the mortgage under this program may be shorter than with the Graduated Payment Mortgage Program. This program may be used with the following programs: One-to-Four-Family Home Mortgage Insurance (Section 203b), Rehabilitation Loan Insurance (Section 203k), Single-Family Cooperative Mortgage Insurance (Section 203n), and Mortgage Insurance for Condominium Units (Section 234c).

With this program, you must choose from one of five payment plans. Each plan raises your monthly mortgage payment by a certain amount during each year of the loan. You must be a good credit risk to use this program. You must also use the home as the main place you will live. You must be able to prove that you will get an increase in income in the future. This program is still active but has received little activity in recent years.

#### i) <u>Insured Mortgages on Indian Land (Section 248)</u>

This program helps you to buy a home or to build a home on Native American land. The tribe that owns the land where the home will be must meet four rules before HUD will approve the loan. First, the tribe must have eviction rules in place and agree to enforce those rules. Second, HUD must be allowed to go onto the tribal land to repair the property if the homebuyer is evicted. Third, the tribe must agree to use a pre-approved lease form. Finally, the tribe must pass a rule that either allows HUD's lien on the home to be a first lien, or that says that state law should decide the priority of the liens. If you are not able to keep the home, HUD will try to sell the home to another qualified Native American homebuyer.

This program is for any Native American who wants to live on Native American land. You must use the home as the main place you will live. You may get up to 97% financing on the loan. You may have a low down-payment. You may also be able to finance your closing costs. You must be a good credit risk. Your mortgage can only be a certain dollar value. How high your mortgage can be depends on where you live. You can find out your area's mortgage limit by going to <u>https://entp.hud.gov/idapp/html/hicostlook.cfm</u>. You can apply for the program through an FHA-approved lender. You can find out more about this program by going to <u>http://www.hud.gov/offices/hsg/sfh/ins/sfh248.cfm</u>.

#### II. <u>Multifamily Housing Programs</u>

These programs are for low-income people seeking housing. These programs are run by the U.S. Department of Housing and Urban Development (HUD). Please call HUD directly for more information about each program at 1-800-685-8470.

#### a) <u>Supportive Housing for the Elderly (Section 202)</u>

This program gives housing and supportive services to eligible families where at least one household member is sixty-two (62) years old or older. The program helps elderly people to live on their own, but still gives them the supportive services that they need. Examples of supportive services are help with cleaning and help with transportation.

To use this program, you must have a very-low income. This means that your income must be below fifty percent (50%) of the area median income. Families who apply must have at least one person in the household who is age sixty-two (62) or older. Single elderly people may also apply. You can find out more about this program by going to http://www.hud.gov/offices/hsg/mfh/progdesc/eld202.cfm.

#### b) <u>Supportive Housing for Persons with Disabilities (Section 811)</u>

This program gives housing and supportive services to people who have a disability. Under HUD rules, a person has a disability if he or she cannot do one or more major life activities because of physical or developmental problems or because of mental illness. Families who apply for this program must have at least one household member who is eighteen (18) or older and who has a disability. The program helps disabled people to live on their own, but still gives them the supportive services that they need. Examples of supportive services are help with cleaning and help with transportation.

To use this program, you must have a very-low income. This means that your income must be below fifty percent (50%) of the area median income. Families who apply must have at least one disabled person in the household who is eighteen (18) or older. Single disabled people may also apply. You can find out more about this program by going to http://www.hud.gov/offices/hsg/mfh/progdesc/disab811.cfm.

#### III. <u>Public Housing Programs</u>

The following programs are run by the Office of Public and Indian Housing (PIH) of the U.S. Department of Housing and Urban Development. Please call PIH/HUD directly for more information on each program at 1-800-955-2232.

#### a) <u>Housing Choice Voucher Program</u>

This program is made up of several smaller voucher programs that let a tenant get rental assistance for homes that are not owned by the government. The voucher programs are usually run by the local public housing authority (PHA) in an area. Tenants in a voucher program are allowed to look for housing that meets the rules of their local PHA. The housing is usually owned by private citizens

instead of the government. Rental units must meet the housing and cost rules set by the PHA.

With this program, you cannot pay more than thirty percent (30%) of their adjusted monthly income to rent a home. The rest of the rent is paid by the PHA directly to the landlord of the home. You must have a low or very-low income to use this program. If you have been evicted from rental housing in the past because of drug-related or violent criminal activity, you may not be allowed to use this program. If you have been evicted for activity that threatens the health, safety, or right of peaceful enjoyment of the property of other tenants, neighbors, or PHA employees, you may not be allowed to use the program. You must be willing to follow both HUD rules and the rules in the lease agreement with your landlord. You can apply for this program at your local PHA. There are several types of vouchers you can get under this program. They include:

- <u>Project-based vouchers</u> You must live in a certain housing building or unit to get this type of rental assistance. <u>http://www.hud.gov/offices/pih/programs/hcv/project.cfm</u>
- <u>Tenant-based vouchers</u> These vouchers are for people who have an income below fifty percent (50%) of the area median income. <u>http://www.hud.gov/offices/pih/programs/hcv/tenant.cfm</u>
- <u>Homeownership vouchers</u> Rental assistance for buying a home and paying homeownership costs. You must be a first-time homeowner. Except for families with elderly or disabled members, the person who applies must have an income below a certain dollar amount. <u>http://www.hud.gov/offices/pih/programs/hcv/homeownership/index.c fm</u>
- **Family Unification vouchers** Rental assistance for when a lack of housing is the main reason that the children in a family have been removed from the household. DSS must state that the family is in this situation.

 <u>Vouchers for People with Disabilities</u> – Rental assistance for people who are disabled under HUD rules. Elderly and non-elderly families may apply. <u>http://portal.hud.gov/hudportal/HUD?src=/program\_offices/public\_ind ian\_housing/programs/hcv/pwd/certain</u>

#### b) **Public Housing**

Public housing is rental housing for low-income tenants. Public housing is usually run by the local public housing authority (PHA) that owns the property. HUD gives money to the PHAs that run the housing. Public housing is available only to U.S. citizens or eligible immigrants.

You can apply for public housing at your local PHA. A list of PHAs in South Carolina is at <u>http://www.hud.gov/offices/pih/pha/contacts/states/sc.cfm</u>. All applications for public housing must be in writing. If you apply, you will have to give basic information on each member of your household. You also have to give proof of your family's income, identification, and other information. You can find out more about this program by going to http://www.hud.gov/offices/pih/programs/ph/index.cfm.

If you are able to get public housing, you must follow HUD rules and the rules of the lease. In order to stay in public housing, at least once each year you will have to prove that your income has not increased.

#### c) <u>Public Housing Homeownership Program (Section 32)</u>

This program helps low-income people buy a home from a public housing authority (PHA). With this program, you usually buy the public housing unit or home in which you are living. In fact, if you live in a PHA unit, you have priority to buy the unit in which you are living.

To use this program, you must have an income that is no more than eighty percent (80%) of the area median income. The unit must be the main place you will live. You must pay a down-payment of at least one percent (1%) of the sale price of the unit. PHAs are allowed to create other rules for buyers under this program. You can find out more about this program by going to http://www.hud.gov/offices/pih/centers/sac/homeownership/index.cfm.

# **U.S. Department of Agriculture (USDA)**

These programs are run by the Rural Housing Service (RHS) of the U.S. Department of Agriculture (USDA). Please call the RHS/USDA directly for more information about each program. You can reach the South Carolina state office of the USDA by going to <u>http://www.rurdev.usda.gov/SC\_Home.html</u> or by calling 1-803-765-5163. #### a) <u>Single-Family Guaranteed Rural Housing Loans (Section 502)</u>

This program makes loans to low-income people or families to buy homes in rural areas. Loans can be used to build, repair, fix up, or move homes. Loans can also be used to buy or prepare land for homes. The home you buy under this program cannot be above a certain price. This price can change depending on where you live. You can also buy manufactured housing through this program. Loans through this program are usually for thirty (30) years. There is no required down-payment.

To use this program, you must not be able to get credit elsewhere. You must also lack decent housing. You must be able to pay the mortgage payments, taxes, and insurance. You must have a reasonable credit history. You may have an income up to one-hundred and fifteen percent (115%) of the area median income for your area. #### b) Single-Family Direct Homeownership Loans (Section 502)

This program is for people and families with low or very low-incomes. Under this program, you can get up to one-hundred percent (100%) financing to buy or build a home in a rural area. The home you buy under this program cannot be above a certain price. This price can change depending on where you live. You can have from thirty-three (33) to thirty-eight (38) years to repay the loan. The amount of time you have to repay the loan will depend on your income and type of home you are buying. You can also buy manufactured housing through this program.

To be eligible, you must have a low or very-low income. However, elderly and disabled homebuyers with incomes up to eighty percent (80%) of the area median income may apply for this program. To apply, you must lack decent housing. You must be able to pay the monthly mortgage payments, taxes, and insurance. You must also be unable to get credit elsewhere. In some situations, you may be able to use this program to get help making the mortgage payments. A reasonable credit history is required. You can find out more about this program by going to <u>http://www.rurdev.usda.gov/HAD-Direct\_Housing\_Loans.html</u>.

#### c) <u>Very Low-Income Housing Repair Program (Section 504)</u>

This program provides loans or grants to very low-income homeowners to repair or improve their homes. You can also use this program to remove health and safety dangers from your home. Loans under this program are one percent (1%) loans that must be repaid over a period of twenty (20) years. The maximum loan amount is \$20,000. The maximum grant amount is \$7,500. Grants can only be used to pay for repairs and improvements that will remove health and safety dangers from the home. Only elderly people who are unable to repay a loan can get a grant under this program. All other homeowners who are approved for this program would get a loan.

To use this program, you must have a very-low income. You must not be able to get low-cost credit elsewhere. #### d) Farm Labor Housing Program (Sections 514 and 516)

This program provides loans or grants to build, buy, repair, or improve rural homes for farm workers. Farmers, groups of farmers, and groups of farm workers can apply for this program. The loans or grants can be used for many things, including buying a home, building or repairing a home, building daycare facilities or community rooms, paying fees to buy long-lasting household goods, or paying construction loan interest. This program can also be used in urban areas for nearby farm labor. Loans are usually for 33 years at 1% interest.

Farm workers who are U.S. citizens or eligible immigrants and whose income comes mostly from farm labor may apply. Farm workers using this program who later retire or become disabled may keep using this program as tenants. You can discover more about this program by visiting:

#### e) <u>Rural Rental Housing Program (Section 515)</u>

This program provides rental housing to people in rural areas. This program is the main rental housing program used to help low-income people in rural areas. To use this program, you must have a very low, low, or moderate

income, or you must be elderly or disabled. Very low income means an income at or below 50% of the AMI. Low income means an income between 50% and 80% of the AMI. Moderate income means an income no more than \$5,500 above the low-income limit for an area.

People who do not have adequate housing have priority for this program. The USDA has a rental assistance program to help people who use this program pay for their rent. When using both programs, most people do not have to pay more than 30% of their income for rent. #### f) <u>Rural Housing Service Multifamily Housing Rental Assistance</u> <u>Program (Section 521)</u>

With this program, tenants who live in low-income rural housing can get help if they do not have incomes high enough to pay their rent. This program is to help elderly, disabled, and low-income tenants. Tenants who already live in USDA rental housing have priority for this program.

If you are approved for this program, you will pay no more than thirty percent (30%) of your income for housing because the program pays the landlord the difference between the tenant's share of the rent and the total monthly rental rate. # **U.S. Department of Veterans Affairs Programs**

These are home loan programs run by the VA Loan Guaranty Service of the Veterans Benefits Administration. Please call the VA to learn more about each program. You can reach the VA at 1-800-827-1000. #### a) VA Guaranteed Home Loan

With this program, United States veterans can get a home loan. These home loans are made by private lenders, not the government. The VA then guarantees the loan for the private lender up to a certain amount. A loan under this program can be used to buy or build a home. It can also be used to repair or improve a home, or to refinance a home loan. The home you are buying must be the main place you will live. You may be able to have no down payment through this program. You may also have limited closing costs, a longer time to repay the loan, and fixed interest rates.

If you are a veteran who has available home loan entitlement, you may apply for this program. To apply, you must get a Certificate of Eligibility from the VA. You must also have enough income to pay the mortgage payments and other costs that come with owning a home. You must have a good credit record. In some instances, the spouse of a veteran may be able to get a loan under this program. You can learn more about this program by going to http://www.homeloans.va.gov/lgyfaq.htm.

#### b) VA Guaranteed Manufactured Home Loan

With this program, United States veterans who want to buy a manufactured home can get a home loan. These home loans are made by private lenders, not the government. The loans are guaranteed by the VA for up to forty percent (40%) of the loan amount or the veteran's available entitlement amount. The loan may be used to buy a manufactured home and lot, to make repairs to a lot already owned, or to refinance a manufactured home loan. You cannot buy a modular home through this program.

If you are a veteran who has available home loan entitlement, you may apply for this program. To apply, you must get a Certificate of Eligibility from the VA. You must also have enough income to pay the mortgage payments and other costs that come with owning a home. You must have a good credit record. ## **Habitat for Humanity International**

This group helps families to have a home of their own built for them. The homeowner family works with volunteers to build a home. The home is sold to the family through a no-interest loan. The family may have between seven (7) to thirty (30) years to repay the loan.

Each homeowner family must pay a down payment on the home and make monthly mortgage payments. The family members must also do some of their own work by helping to build their family's home or the home of another family. This work is called "sweat equity". The number of sweat equity hours a family must earn will vary depending on where the family lives.

Families are chosen for this program based on many factors. Some factors are the family's need for a home, the family's desire to work on the home, and the family's ability to repay the mortgage loan. Only families who do not already have decent housing can use this program. To apply for this program, please contact your local Habitat for Humanity office. The SCSHFDA runs the State Housing Trust Fund and is the local housing authority in several South Carolina counties.

# **South Carolina Department of Mental Health**

#### Shelter Plus Care

This program is a HUD-funded program that provides rental assistance and supportive services to homeless people and families with disabilities. The rental assistance is used to get permanent housing for those who apply. Many types of housing are available under this program. For example, single unit housing (1, 2, or 3 bedrooms) is available under this program. The rental assistance given under this program must be matched dollar-for-dollar with supportive services equal in value to the rental assistance given. Examples of supportive services are primary health care, mental health care, case management, addiction care, and other services.

The Shelter Plus Care program is meant for people and families who are either living in places not meant to be lived in or who are living in emergency shelters. Homeless people or families who are mentally ill, or who are mentally ill and also have severe alcohol or drug addictions or HIV/AIDS may apply for this program. Tenants pay rent that is no higher than thirty percent (30%) of their monthly adjusted income. Rent is calculated based on the same HUD rules as used in the Section 8 program.

In South Carolina, you can apply for the Shelter Plus Care program through the South Carolina Department of Mental Health's local mental health centers. There are seventeen (17) local mental health centers across the state. A list of these centers can be found at <u>http://www.state.sc.us/dmh/consumer\_housing.htm</u>.
